

Judiciary Goals. AMHF is working on a couple of judiciary statutes that focuses on the victims of domestic violence and then on the perpetrator of the abuse and crime. Leading the way is our board member Joe Goethals, Deputy DA who is directly involved in the domestic violence unit in San Mateo County. The first initiative is to mandate a training class (to increase awareness & prevention) for victims who are in the cycles of violence. Often times the victim will want to modify or drop the restraining order against a defendant because the victim wants to have contact with the defendant; they tend to "fall for the apologies". Before a restraining order can be modified, the victim will be given the opportunity to take this training. The content will

contain data from the experts in the community; impactful information that can be transformative for the individual if she is willing to take the steps so that she no longer has to be a victim of DV.

The second initiative has to do with domestic violence defendants in the court system. They are known to have a mental illness diagnosis, have a history of DV (repeat offenders with escalating violence), who violate restraining orders and are obviously a high threat thus, should be contained at once before any bail motion is considered. A comprehensive risk assessment [CRA] by a psychiatrist should be performed. The CRA would be used as a tool by prosecutors that would uphold the argument that bail should be raised or support the decision that the defendant should not be released from custody; that the psychiatric diagnosis means that they are less likely to be amenable to probation and for that reason, should stay in jail. The results from a CRA could quite possibly be a barrier for a defendant to get out on bail and then go fatally hurt someone.

These initiatives are sound in there applicability and we aim to make them a reality in the next 12 months. Friends and family are welcome to contact us and comment should you have insight or experience on these topics in our legal system.

We have him as well as Dr. LuoLuo Hong also of SFSU to thank in setting the wheels in motion.

The video is intended for academic audiences such as, college freshman and junior transfer students as an integral part of their orientation package. Currently, we are in new discussions with the staff at SFSU (Dept. of Student Affairs). A consensus has been reached that AMHF and the Dept. of Health Promotion & Wellness would partner in developing the content, production, and distribution of this video. HP & W would also assist in engaging the School of Cinema as appropriate as well as connecting our Foundation with students. We are hopeful that at the end of next quarter, we will have taken more concrete steps in getting this video off the ground.

Turning a heart shattering tragedy into hope for victims of violence


All of these endeavors would not be possible without your generous contributions to AMHF. Thank you.
